- Igal Treibatch, Secretary
  - Getting closer and closer to understanding the White Area and SGMA.
  - There is currently a bill in Sacramento that would limit water usage to 55 gallons per person per day, which would be very bad.
  - Working with an attorney to create a system for credits for water recharge.
  - \$500,000 grant needs 25% matching so better to get partners to put up money if we create credits.
  - Igal offered to write next article for Ranchos Independent on White Area/SGMA or ending of low flow grant ("use it or lose it").

  - Al attended the Ag roundtable on June 15, which focuses on Ag conservation easements
  - Statewide conference on water conservation coming up in Sacramento July 26-27
  - Gathering of Peacemakers in Yosemite in October focuses on three areas including Environment,
     Youth and Dignity
  - 80 projects being considered, which will be ranked by P&P
  - Workshop focusing on disadvantaged community involvement funding this Sun, June 24
  - Workshop Subbasin SGMA Monday, June 25 at Farm Bureau

## - Grant Reports

- Report from Owen Kubit Jennifer read from Owen's email
  - 2014 Water-Energy Grant. This grant is winding down. We should keep giving out devices in the inventory, but otherwise have stopped spending money for the grant so we can wrap up the invoicing and reporting. We have requested a 2 month extension to prepare the final report.
  - 2016 Water-Energy Grant. All is going good. We now have approval for dishwasher rebates. Please spread the word. I will finish a progress report for approval this week.
- Report from Anthony Forestiere Jennifer read from Anthony's email
  - Clif Bar Foundation denied our request for general operating funds.
  - Still have active applications with Walmart Foundation (4 different grant requests for ongoing operations funding).
  - Applied for \$5,000 ongoing operational support with Rose Foundation (Northern California Grassroots Grant)
  - Applied for \$5,000 ongoing operational support with Chukchansi Gold Resort & Casino (Community Grant)
  - Will be applying for other grants upon his return om the 26th.
