- Igal spoke to someone there to get estimate on Accounting
- Previous accountant asked if SEMCU would take on responsibility of their Accounting;
 SEMCU had said no and is still no
- Wondering if he RWMG meetings are covered by the Brown Act; Bobby will research with the County Council
- Chowchilla Nitrate Control Program Suggested to give \$50 gift cards to each of first 50 people who becomes applicants
- Indian Lakes / Parkwood 38% installation complete; projected April completion; project under construction in Madera 2 projects in design stage; City of Chowchilla starting soon
- SGMA projects implementation 4 projects in process, being delivered to DWR
- Discussed drought working group; application of \$125,000 grant approved by DWR to monitor wells in Madera Ranchos area; reviewing draft agreement with DWR
- Al will check on when \$\$ will next be available for grants
- Igal wants to contribute to the \$1M recharge well planning & SEMCU to support

■ New Business Discussion Items

- Igal got double-side flyers emailed to all parents of GVSD for donating items
 - Newspaper Ad Putting donation flyer in paper for March or April (5,000 printing) Suggesting now having high school clubs distribute 300 flyers to businesses printed on a thicker paper. Summer can distribute some to the Golden Valley Baptist Craft Fair Saturday
 - Motion: Igal: Print flyers & distribute
 - 2nd Summer Skov
 - Vote All in favor
- o Margaritas and Lunch at the Mahils' Sunday, May 5th Madera Farm Bureau
 - Motion: Igal: Sponsor by donating \$500, which allows one SEMCU person to attend
 - 2nd Al Solis
 - Vote All in favor
- Madera Farm Bureau Sent out an article stating an almost 68% loss of family farming operations in 6 years due to lowered college education enrollment on agriculture. Igal read how Madera County is working with the GSA & Sustainable Groundwater Management Act (SGMA) regarding water recharge and credits. The State wants to take control of water use and limit to 6 inches of water only. Igal will keep supporting farm use by speaking to people in the County and sent a letter on his ideas (to Matt Draper Head of Staff in Madera County and Stephanie Anagnoson, County Director of Water and Natural Resources and Darren, Educational Economic Development).

- Upcoming Flatlander's Parade
 - Parade Route Igal will speak to supervisor (Jordan) on route. Verlaine has information
 that the City will discuss this month. They want to "walk the route" and Igal wants to
 participate. Verlaine said Mika (Chief of Staff) is coordinator. Grand Marshal chosen,
 possibly Ralph Pistoresy. Igal would like to ask for an ambulance available for kids to look at
 for learning, as well as Sherrif and Fire Department vehicles.
- o Flatlander's Fair Follow-Up Regarding volunteers to run the booths Flatlander's Fair
 - Verlaine will get information about booth placement. Igal wants to attend meetings.
 - SEMCU is donating \$1,000 from SEMCU to sponsor fair operations Donating to Chamber of Commerce – Chamber will give Verlaine what they need and then Verlaine will write the check.
 - Pick up items by coordinating with Verlaine & Scott: providing truck & trailer, storing until the day of the fair. Verlaine, Igal, and Scott discussed picking up items.
 - Raffle at the fair Tickets being given out as they donate items for sale. Prizes can be the bigger donated items or \$100 gift cards.
 - Motion: Donated items & gift cards will be given as prizes.
 - 2nd Verlaine
 - Vote All in favor
 - Some donated items being dropped at Verlaine's is garbage & Scott will pick up and toss as garbage. Good items will be stored at shop. Scott will need to make an invoice that shows his time spent on SEMCU and SEMCU can pay it with a check from Pegasus. Greenleaf will donate to SEMCU for that check
 - Donation of time Worker needs to create an invoice & Verlaine pay w/ check
